GUIDELINES – Open call is announced for artwork to be considered for the “One to Six” Art Purchase Award. The City of Lawton and the Lawton Arts & Humanities Council (LAHC) sponsor this art purchase award. The LAHC’s Program Committee serves as jury, making recommendations to the LAHC for the purchase of six pieces of artwork from one artist. The artwork in turn is presented to the six people who win the 2019 Cultural Awards. The award is \$900.00 for the six pieces.

Past recipients of the “One to Six” have been Jenny Perry, Mosaic; Janie Griffin, custom silver jewelry; John Hernandez, hand painted gourds with woven pine needles; Santos Rubio, Macro-photography; and Tom Biggs, watercolor just to name a few! REQUIREMENTS:

Appropriate to the integrity and intent of the Lawton Cultural Awards for Roma Cliff Montgomery Citizen of the Arts, Roma Cliff Montgomery Citizen of the Humanities, Educator in the Arts, Educator of the Humanities, Artist of the Year and Business/Organization in Arts. These individuals are recognized for their significant contributions.

Theme is open but should be appropriate to the Cultural Awards.

All artists are eligible, no entry fee with only six (6) works allowed per artist.

Do not send actual artwork for consideration, photos only. Label each with artist name, contact info and title of work if any. Submit an artist statement with contact information.

Two and three-dimensional works considered. Submit photos of artwork: 1 photo for 2-D works and 3-photos for 3-D (top and sides) works.

Size limit: Each art work should be less than 24” in any direction.

All media considered includes limited edition fine art prints or photographs.

All artworks need fine art presentation where artwork, including frame and matting as well as any base, should be made of archival materials.

Area reserved (estimate 1-2” x 3-4”) for a plaque.

Submissions can be mailed or delivered to the Arts & Humanities Division

Artist retains copyright and must approve of photographic use of image of advertising, education, publicity and display materials.

City of Lawton and LAHC is not obligated to offer award if it is determined that there is not an appropriate artwork submission.

This agreement does not include the use of said image for commercial endeavors such as photo reproduction for sale or use in "for fee" products. I do not waive or assign the copyright for this artwork.

In addition, I waive the right to inspect or approve the finished product, including written or electronic copy, wherein the image of the artwork appears.

I understand that where possible, the artist's name, artwork name, and other information about the artwork will be prominently listed. I also understand that this release and agreement in no way creates an obligation or requirement for the City of Lawton and its boards, trusts, and commissions to use images of my artwork.

I hereby affirm that all artwork covered under this agreement are originals and created by me and/or that I legally own or possess said artwork; that I own or possess the rights granted under this agreement, and that the rights granted hereunder are not encumbered by any other agreement which would conflict with this agreement.
