

**April 22<sup>nd</sup>, 2020 Supplement to Exhibit A  
of the April 3<sup>rd</sup>, 2020 Civil Emergency Proclamation**

**Whereas**, following the declaration of a civil emergency by proclamation, Lawton City Code Section 8-1-119 authorizes the Mayor and Mayor Pro Tem acting in concert to issue such additional orders in the interest of public safety and welfare.

**Whereas**, a proclamation declaring a civil emergency was issued on March 16, 2020, for the City of Lawton. A subsequent proclamation was issued on April 3, 2020, extending the declaration of civil emergency until 11:59 p.m. April 30, 2020. The April 3, 2020, proclamation also authorized the issuance of additional and/or modified orders pursuant to the authority granted in Lawton City Code Section 8-1-119. Such additional and/or modified orders shall be published as an Exhibit “A” to the current proclamation.

**Whereas**, as a result of the changing emergency circumstances the following emergency order is being issued by the Mayor and Mayor Pro Tem acting in concert in the interest of public safety and welfare.

**City of Lawton  
Emergency Order A-3  
DATED April 22<sup>nd</sup>, 2020**

Unless modified herein, the provisions of this order will supplement the orders set forth in the April 3, 2020, proclamation, the April 9<sup>th</sup>, 2020, Emergency Order A-1, and the April 15<sup>th</sup>, 2020, Emergency Order A-2.

**It is hereinafter ordered:**

**A-3.1 Curfew and Gathering Limits**

- I. Effective immediately, the Curfew previously established (11 p.m. to 5 a.m.) shall only apply to those under the age of 18.
- II. Effective immediately, the limit for essential activity gatherings is raised from six (6) to ten (10). This is consistent with the Governor’s Emergency Order currently prohibiting groups of “more than ten.”

### A-3.2 Retail Occupancy Limits

- I. Store managers shall be responsible for ensuring the maximum allowed store/building customer occupancy limits are adhered to. This limit shall be determined by the following:
  - a) For buildings with a square footage of 75,000 square feet or larger, the customer occupancy level will be 150.
  - b) For buildings of less than 75,000 square feet, but more than 1,000 square feet, the number of square feet of the building shall be divided by 500 to determine the new reduced customer occupancy level.
  - c) For buildings of 1,000 square feet or less, the customer occupancy level shall be two (2).
- II. Big Box Stores with Garden Centers/Nurseries shall have separate/additional occupancy limit requirements. These requirements include:
  - a) Garden Center/Nursery portions of large “Big Box” Stores remaining open to the public, shall have a Garden Center occupancy limit of no more than 30 customers at any given time within the Garden Center area(s).
  - b) If the additional occupancy limits listed directly above cannot be adhered to, the Garden Center/Nursery portion of the store shall be closed to the public.

### A-3.3 Faith-Based Assemblies

- I. Persons 65 years and older are encouraged to continue to maintain the “Shelter at Home” CDC/State/City guidelines, as per the Governor’s Emergency Order. However, if members of this COVID-19 vulnerable population attend drive-in faith-based services, they are asked to strongly consider keeping their windows raised to a high elevation point and wearing facemasks.
- II. Faith-based assemblies of more than 10 people shall now be allowed for “drive-in” type services only, but must follow the established requirements and safety measures as follows:
  - a) Such drive-in faith-based services may be performed in parking lots of the church property.
  - b) The preferred method for providing drive-in services is via FM radio frequency broadcast to vehicle radios. However, to better allow for drive-in faith-based services, the City’s sound ordinance shall be waived during allowed drive-in service times. These

services shall be limited to between 10 a.m. to 2 p.m. on Sundays until the expiration of the Emergency Proclamation. Should a particular faith have need that is outside of these hours and/or weekday, and upon providing a 5-day notice, a request for waiver may be granted by the Mayor/Mayor Pro Tem.

- c) Vehicles attending drive-in faith-based services shall maintain an empty parking space between other vehicles.
- d) There shall be only one household/family per vehicle in attendance.
- e) Occupants of vehicles attending faith-based services shall remain in their vehicles with doors closed but may have windows open.
  - i. One exception to the in-vehicle requirement is for the purposes of using the church restroom, but only with the following requirements:
    - 1) Hand sanitizer and/or sanitizing wipes shall be available for anyone entering/leaving the building and/or restrooms.
    - 2) Only one attendee at a time shall be allowed out of their vehicle to visit a restroom, unless it involves a child or other family member needing assistance. In this instance, two shall be allowed. Door handles shall be sanitized by the adult as the adult exits.
    - 3) An adult church team member shall be stationed to ensure sanitization of door handles etc. is performed after each use.
    - 4) Attendees outside of their vehicle for this purpose shall maintain social distancing of 6 feet minimum, with no direct contact from church staff or another attendee.
    - 5) Facemasks are strongly recommended when outside of a vehicle and/or when inside the church.
- f) Church service staff participants, outside of vehicles (Pastor/Sound Person/Praise and Worship Team, etc.) shall adhere to the following:
  - i. Be limited to no more than 10 persons.
  - ii. Such persons shall at all times maintain social distancing of a minimum of six feet and shall have no direct contact with other persons.
  - iii. When not speaking/singing as a part of the service, it is recommended to wear a face mask.
  - iv. Hand sanitizer/sanitizing wipes shall be available to staff participants.
  - v. When utilizing written communication/handouts, doing so with prepacked elements should be distributed at a single point by church service staff members who shall wear a face mask and ensure social distancing requirements are maintained. No direct contact is permitted.

- vi. Any potential direct counseling of attendees by church staff shall require maintaining social distancing guidelines of a minimum of 6 feet, shall involve no direct contact, and shall require the wearing of a facemask.
- vii. Although online or mailed giving is encouraged/preferred, when performing a collection of offerings:
  - 1) The offering collection shall be limited to one person performing such collection.
  - 2) The wearing of a mask by the offering attendant is mandatory.
  - 3) A drop off point is preferred to a car pick-up of offerings.
  - 4) Direct contact is not permitted between the offering attendant and those offering a gift. Therefore, the utilization of a basket is required, preferably a basket with a long handle to help ensure social distancing requirements.

III. Any person that may walk up to an active faith-based service shall be required to maintain social distancing requirements a minimum of 6 feet from other persons, and/or from vehicles with passengers. Non-congregants shall make no direct contact with anyone else in attendance. And there shall be no gathering of walk up attendees of more than ten people.

#### A-3.4 Certain Recreational Activities

I. Tennis shall be allowed under the following required safety standards:

- a) Tennis shall be limited to one person on each side of the net/court. Therefore only “singles” tennis is currently allowed and no “doubles” tennis is permitted.
- b) Social distancing of a minimum of six feet shall be maintained between players and/or spectators at all times.
- c) If equipment is shared, it shall be sanitized before and after use. Tennis balls shall not be shared. However, because it is typically necessary for only the server to touch/hold the tennis ball, it is required that each person serve with their own tennis ball(s). This minimizes the potential for cross contamination between players.

II. Boating, including for purposes of fishing and or other recreational uses, shall be allowed on City lakes, but only under the following restrictions:

- a) Individuals must adhere to all applicable laws and ordinances, including being properly permitted.
- b) New boating permits will be limited to those demonstrating proof of ownership of the boat being permitted *and* either proof of residency in Comanche County or

demonstrating proof of a long-term lease on City lake property that predates the effective date of this Order.

- c) Unless boating with family members, and/or others that all reside together, social distancing of a minimum of six feet shall be maintained. This requirement includes while on City property off the lake as well, including while on the boat ramp.
- d) Gatherings of more than 10 people are prohibited.
- e) Personal kayaking and paddle-boarding is allowed under the above applicable rules.
- f) Tubing, wakeboarding, etc. and/or personal watercrafts such as jet skis, sea-doo's, etc., shall only be allowed with family members residing together and/or with others that reside together in the same home.

III. Camping in all designated City controlled camping areas shall be allowed under the following restrictions:

- a) Only one Recreational Vehicle (RV) per rented camping space is allowed in campgrounds provided for those vehicles.
- b) New camping rentals shall be limited to those demonstrating proof of residency in Comanche County or demonstrating proof of a long-term lease on City lake property that predates the effective date of this Order.
- c) Only one family per RV or only members who reside together in a given permanent residence shall be allowed to share an RV on City campgrounds.
- d) Only one family per camp site or only members who reside together in a given permanent residence shall be allowed to share a camp site.
- e) No gatherings of more than 10 people are allowed.
- f) If visitors – individuals not of the same family and/or not sharing a residence – are in the camping vicinity, social distancing of a minimum of 6 feet shall be maintained at all times outside of the RV or tents.
- g) It is recommended to users of the campgrounds providing for RV's, to do so with only RV's that have fully self-contained bathrooms.

**Unless otherwise specifically indicated within the provisions listed in this Order the provisions of this Order shall take effect immediately upon execution of this Order on this 22<sup>nd</sup> day of April 2020.**
